

Subject: ACTION REQUIRED for your 2025-2026 Fluzone [®] (Influenza Vaccine) multi-dose vial reservation

Dear Valued Sanofi Customer,

On July 23rd, the U.S. Department of Health and Human Services (HHS) adopted the Advisory Committee on Immunization Practices (ACIP) recommendation to remove thimerosal from all U.S. influenza vaccines. Sanofi has sufficient supply of Fluzone prefilled syringe (PFS), which does not contain thimerosal, to support customer preference of influenza vaccines and help maximize access for patients this upcoming season.

Update to your influenza reservation

As part of your influenza reservation, you requested Fluzone multi-dose vial (MDV). We are reaching out to confirm your choice of vaccine presentation prior to shipment. In light of the recommendation change, Sanofi will not ship MDV without your confirmation of either your original order or a change to another product selection. Should you prefer thimerosal-free prefilled syringes for the coming 2025-2026 season, we have ample supply to accommodate a modification to your order. To ship your order, please contact our customer service department at 1-800-VACCINE (800-822-2463) to confirm your MDV reservation or to discuss modifications. Please also be aware there is a nominal price difference between the Fluzone PFS presentation and the MDV presentation, which may require an update to your purchase order.
